### STEP ONE: DECIDE TO DONATE!

THIS MEANS YOU WILL BE ABLE TO REDIRECT YOUR TAX DOLLARS BACK INTO OUR COMMUNITY! A UNIQUE PROGRAM EXCLUSIVE TO ACCREDITED MAIN STREET COMMUNITIES, LIKE SNOHOMISH. ANY WASHINGTON STATE BUSINESS IS ELIGIBLE TO DONATE TO HDSA, INSIDE AND OUTSIDE OF HISTORIC DOWNTOWN SNOHOMISH
